If you have other family members on the plan, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Preventive care/screening/immunization, Primary Care, Specialist Care, Urgent Care, Mental/Behavioral Health Outpatient Services, and Substance Abuse Outpatient Services do not apply toward the deductible. 
