Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care/screening</u> /immunization, Primary Care, <u>Specialist</u> Care, <u>Urgent Care</u> , Mental/Behavioral Health Outpatient Services, and Substance Abuse Outpatient Services do not apply toward the <u>deductible</u> .
