Subject: Breast Cancer Screening of Women with Schizophrenia – An Opportunity for Improvement

Women with schizophrenia and psychotic disorders are less likely to receive preventive cancer screenings.ⁱ As a result, the incidence and mortality rates of breast cancer in women with pre-existing severe mental illness, such as schizophrenia is higher relative to the general populationⁱ. Contributing factors including payor type, PCP utilization and late entry into treatment.^{ii, iii}

AmeriHealth Caritas Next/First Choice Next is seeing similar screening disparities where less than 17 percent of eligible women with schizophrenia received mammograms. As an AmeriHealth Caritas Next/First Choice Next Behavioral Health Provider, I am requesting your support to combat this disparity.
